



2024 Christmas Raffle Official Rules and Regulations

The 2024 Christmas Raffle Fundraiser (“the Fundraiser”) is governed by the Ontario Lottery and Gaming Corporation (“OLG”) lottery license number #M847915. The fundraiser is conducted, managed and fulfilled by the Precious Minds Support Services (“the Sponsor”, “Executive Director” and “Fund Development Coordinator”).

The fundraiser commences on November 1, 2024 and ends on December 6, 2024 at 4:59:59pm (the “Contest Entry” period).

By entering this fundraiser, entrants accept and agree to be bound by these Official Rules and the decisions of the Executive Director and Fund Development Coordinator (Precious Minds Support Services) which are final, binding and conclusive on all matters related to this fundraiser.

1.0 ELIGIBILITY: This contest **is only open to** those who are: a) residents of Ontario; and b) 19 (nineteen) years of age or older at the time of registration.

1.2 Notwithstanding the forgoing, the Contest **is not open to:**

- a) Precious Minds Support Services Executive Director and Fund Development Coordinator
- b) Residents outside Ontario

2.2 Entrants are limited to winning one prize.

3. HOW TO ENTER:

Enter the fundraiser by contacting Julia Faust, admin@preciousminds.com or 905.982.0882 to obtain paper ballots. Complete ballots for \$10 each or 3 for \$25 with Name, Address, Phone, Email.

Ensure only one name appears on each ballot. If two people split a ticket, then only one name may appear per ballot.

3.1 Acceptable payment methods include etransfer (admin@preciousminds.com, VISA call (905) 982-0882, or cheque payable to *Precious Minds Support Services Lottery*.

3.2 Distribution of ballots: Ballots will be distributed on a first come, first served basis.

4. PRIZING & DRAWS:

A total of Five (5) prizes are available to be won for this fundraiser. The Prize Draw will be held on December 10, 2024, at 9:30am at Uxbridge Baptist Church (231 Brock Street W, Uxbridge ON L9P 1B1) by our Skills for Life Participants. All eligible entries received during the Fundraiser Entry Period will be submitted into the draw to be held after the contest closes on or around December 10, 2024.

Prize claiming details will be provided at the time of contact. If winner requires delivery of prize it will be at the cost of the prize winner. If no winner is declared for any prize, that prize will not be awarded.

The Sponsor, Executive Director, and Fund Development Coordinator assume no responsibility for: entries lost, stolen, delayed, damaged or misdirected.

With respect to this Fundraiser, all decisions of the Sponsor, Executive Director, and Fund Development Coordinator are final.

Name and town of prize winners may be posted, published or announced on the Sponsor's website, or any other media for up to six months after the selected participant is confirmed as the winner.

In the event of any conflict with any provisions contained in these Fundraiser Rules and Regulations and Fundraiser details contained in any form of promotional material or media ("Fundraiser Materials"), these Fundraiser Rules and Regulations shall prevail.

Draw dates and times are subject to change without notice

All winning entries for the contest will be destroyed on or after December 18, 2025 and all other entries for the Fundraiser being destroyed on or after December 18, 2025.
